

Retainer Agreement for:

A \$2500 retainer is required for new cases. A \$1500 retainer is required for consultation case work only. All cases will be billed a minimum of \$500 for secure conflict of case. Invoices will be submitted via email at the close of each month, or as requested, to reflect case work. Payment shall be due within 30 calendar days after submission of invoice. Past due payments will incur a 10% monthly fee on unpaid balances, until paid in full. **The retaining attorney/firm is responsible for payment of services, not the attorney's client.** (Note: Our fees are based only on the amount of time and travel we spend in performing the assignment and are never contingent upon the outcome of the case. If we develop unfavorable preliminary findings for the client, we will stop work until we are able to discuss our preliminary findings with our client so as to minimize unnecessary expenses.)

All testimony including depositions, trials and hearings, require a minimum four (4) hour appearance fee. This fee MUST be received five business days before the deposition unless agreed to otherwise and confirmed in writing. If fees are not received within the allotted time, we reserve the right to reschedule until such time payment is received. Appearance for depositions or trial will not be scheduled on any past due accounts.

All work will be billed accordingly to the fee schedule as follows:
